

WIN 4 MAVS HOME GAME (03-10-2019) OFFICIAL CONTEST RULES

1. How to Enter the Promotion:

- These rules govern the “Win 4 Mavs Tickets” promotion (the “Promotion”) being conducted by Business Class News LLC (“BCN”) beginning on Wednesday, Monday 4th February, 2019 at approximately 12:00am Central Standard Time (CST) and ending on Thursday, February 28, 2019 at approximately 11.59pm CST.
- To participate in the Promotion, entrants must visit the BCN website at <http://acb.businessclassnews.com/contest> and visit the Promotion’s official entry page where they must complete and submit their entry. Entry forms must include your first and last name, phone number, company name if applicable and their valid email address. All entries submitted become the sole property of BCN and will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by BCN. BCN’s computer is the official time keeping device for the Promotion. BCN is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems. All entries must be received by Thursday, February 28, 2019 at 11:59pm CST.
- One (1) randomly selected contestants will be announced no later than 5 days prior to the game day. Contest times may vary. BCN is not responsible for service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her entry. BCN is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches. Due to delays in the BCN online streaming of its content, readers, visitors, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air Promotions.

2. Eligibility Restrictions:

- The Promotion is open to all persons who are 21 years of age or older and who reside in the immediate 12 counties in the Dallas/Fort Worth metropolitan area. Employees of BCN, its licensee, the licensee’s parent, subsidiary and affiliated entities, the members of their immediate families (spouse, parent, sibling or child) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- Online Visitors, Listeners are eligible to win a prize in a promotion conducted by BCN only once every sixty (60) days. Only one (1) winner per household is permitted in any Station promotion.
- Winners will be required to sign a liability and publicity release and show a valid government issued photo identification card and social security card to claim prize. Winners must also submit a copy of the bill that is being paid with the account numbers blacked out or removed.
- Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. BCN will disqualify any entry from individuals who do not meet the eligibility requirements. BCN will also delete any entry knowingly received from persons under the age of 13 in compliance with the Children’s Online Privacy Protection Act.

3. Prizes:

- Prizes will be awarded in the form of officially issued tickets and will be held at the Americas Chamber for Business offices, which will be communicated to the winner until the winner has

claimed the prize at the Americas Chamber for Business offices, presented all required documentation, and signed all required releases and tax forms. The prize can be mailed to the winner within 6-8 weeks of winning if there is enough time. BCN is not responsible for the safe arrival of a prize. BCN is not responsible for any late delivery of the prize.

4. Selection of Winners:

- Decisions of BCN management with respect to the Promotion are final.
- Winners must enter via the online contest page but do not need to be present to win.

5. Conditions:

- Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$1,000 or more or for any prizes awarded by the Station in a calendar year with an aggregate value of \$600 or more. Such winnings of \$600 or more will be reported to the IRS.
- By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Station that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate or modify the Promotion.
- BCN, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of BCN's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If BCN makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, BCN reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- BCN reserves the right to make changes in the rules of the Promotion as we determine, and shall not be required to award a substitute prize.
